**Purpose:** The Child Abuse and Neglect Minor is designed to provide students from a wide range of majors with knowledge, skills and training in prevention, identification, and intervention of child abuse and neglect. This minor would provide visibility for securing employment in careers where child abuse and neglect are encountered and addressed, and thus be valuable for students interested in becoming teachers, principals, and other school personnel; physicians, nurses, and other health care workers; mental health and substance abuse professionals; coaches and athletic staff; child care providers; juvenile justice workers; lawyers; law enforcement officers; and social workers.

The minor consists of 14-15 credit hours. At least 6 hours must be at the 3000-level and above. Some courses in this minor have pre-requisites. Please consult the course bulletin before enrolling in classes.

**Child Abuse and Neglect Minor program guidelines:**

**Required for graduation:** No

**Credit hours required:** A minimum of 14 credit hours. 1000 level courses will not be counted in the minor. At least 6 credit hours must be at the 3000 level or above.

**Transfer and EM credit hours allowed:** A student is permitted to count up to 6 total hours of transfer credit and/or credit by examination.

**Overlap with the GE:** A student is permitted to overlap up to 6 credit hours between the GE and the minor.

**Overlap with the major and additional minor(s):**

- The minor must be in a different subject than the major.
- The minor must contain a minimum of 12 hours distinct from the major and/or additional minor(s).

**Grades required:**

- Minimum C- for a course to be listed on the minor.
- Minimum 2.0 cumulative GPA for all minor course work.
- Course work graded Pass/Non-Pass cannot count on the minor.
- No more than 3 credit hours of coursework graded Satisfactory/Unsatisfactory may count toward the minor.

**X193 credits:** No more than 3 credit hours.

**Minor Approval:** The minor may be approved by the student's College/School Advising Office via the Degree Audit Report (DAR). If the minor is not complete on the DAR, the student must consult with a College of Social Work advisor.

**Filing the minor program form:** The minor program form must be filed at least by the time the graduation application is submitted to a college/school advisor.

**Changing the minor:** Once the minor program is filed in the college office, any changes must be approved by the academic unit offering the minor.
